MARATHON COUNTY MILK HAULER PERMIT POLICY - SEASONAL WEIGHT POSTING

THIS MILK HAULER POLICY WAS ESTABLISHED ON 4-3-2008 THE POLICY STATES: MARATHON COUNTY HIGHWAY DEPARTMENT ISSUE PERMITS TO VEHICLES TRANSPORTING MILK FROM THE POINT OF PRODUCTION TO THE NEAREST MAIN UNPOSTED ROAD ALLOWING LEGAL LOADS ONLY AS PROVIDED IN S.S. 348.15(3)(C)(BG). THE HAULER WILL WORK WITH THE COMMISSIONER TO ESTABLISH THE MOST DIRECT ROUTE, HAVING THE LEAST IMPACT ON THE COUNTY HIGHWAYS; THE LEAST IMPACTED ROUTE NOT BE THE SHORTEST ROUTE. THIS POLICY ONLY AFFECTS COUNTY HIGHWAYS AND DOES NOT EXEMPT THE MILK HAULER TO HAUL OVER ANY POSTED BRIDGE OF WHICH THEY EXCEED THE POSTED WEIGHT. THE MILK HAULER SHALL PAY ON ANNUAL PERMIT FEE AT THE CURRENT RATE.

THIS PERMIT MUST BE REVIEWED AND RENEWED ANNUALLY

CURRENT PERMIT FEE IS \$50.00
